The Company also hereby notifies the market that an application will, in due course, be made to the London Stock Exchange for a total of 4,366,400 Shares which may be issued in connection with the exercise of vested options pursuant to PensionBee Limited’s EMI share option scheme and non tax-qualifying option scheme described in the Prospectus when options vest and are exercised following Admission. These Shares will be reserved under a block admission to trading and may be issued following exercises of options following Admission in connection with PensionBee Limited’s EMI share option scheme and non tax-qualifying option scheme. When issued, these Shares will rank *pari passu* with the existing Shares.
